# Terms & Conditions

## Prices

Prices are subject to change without notice. All prices are for single units unless otherwise stated and exclude GST. All prices are in Australian dollars.

## Bulk purchases

## GST

All prices exclude GST.

## Payment

Invoices are treated as C.O.D. unless otherwise arranged. K-9 Homes reserve the right to refuse supply when accounts become outstanding beyond agreed terms. Overdue accounts will be subject to interest fees at the rate of 3.00% monthly. When an account becomes unreasonably overdue the account will be passed for collection to a retrieval agency and the cost of any such action will be automatically added to the existing account.

## Settlement terms

Invoices paid within 14 days of invoice date are subject to a 3% settlement discount. Payment must be received by K-9 Homes within the 14th day to receive this discount.

## Freight

Freight will be charged to the purchaser. Goods will be sent through K-9 Home's nominated carrier unless otherwise specified or arranged by the purchaser.

## Insurance

Insurance is on the onus of the purchaser unless otherwise arranged.

## Claims & credits

Claims for shortages, breakage and/or incorrect goods must be made within seven days of receipt of the goods. **NO CLAIMS WILL BE RECONISED AFTER 7 DAYS.** All claims must be accompanied by a credit/returns form and authorised by a K-9 Homes staff member. Where goods are to be returned with freight charges to K-9 Homes, we reserve the right to nominate the carrier. For any goods returned without prior arrangement freight will be at the customers expense. In some cases returns may attract a 5% re-stocking/re-packaging fee.

## Back orders

Back orders will be supplied when available unless otherwise arranged at time of sale.

## Guarantees

All goods supplied by K-9 Homes are guaranteed against defects in materials and craftsmanship.

## Sizing

Due to manufacturing process sizing of products may vary slightly.

## Patterns & colours

K-9 Homes reserve the right to change or discontinue products, colours and patterns at any time without notice.

## Title of Goods
